MISTAKE #1

Trusting the Insurance Adjuster

Insurance adjusters are in the business of paying the least amount of money for an injured party's case. Insurance companies have a fiduciary duty to their shareholders to maximize profits and one of the best ways they can do this is by paying an injured party less than the value of their injury case. The adjuster is not looking to help you and may even lie to you to obtain this objective. Let me explain this point by way of a brief example, I was contacted by an injured party who advised me that the insurance adjuster told him that he could not recover any money for his case because he was 1% at fault. I advised him that the insurance adjuster had completely misstated the law and had lied to him. I told him exactly what he needed to do to obtain money damages for his case without the need to hire a personal injury lawyer. He was able to obtain over \$20,000, on his own, without having to pay any legal fees. If he had not talked to me, chances are that he would have walked away from this claim and the \$20,000 that he was paid.

If you attempt to represent yourself, in dealing with your dog bite case without consulting with a lawyer, you will be at a distinct disadvantage because insurance adjusters are trained professionals who are looking to pay the least amount of money possible for your injury case. Many people who have been bitten by a dog attempt to handle their case by dealing directly with the insurance adjuster. Once the person realizes that there are significant complications involving their case, they then contact a dog bite lawyer. One of the problems could be that the person will have made a number of mistakes that could seriously reduce the value of their case or might even destroy it.

You need to understand that not every dog bite case requires the assistance of a personal injury lawyer but every individual who was been injured in a dog bite case needs to consult with an attorney so that individual can get educated about what they need to do, what they should not be doing, how they can get better medical care, how they can get better quicker, and how they can get the best medical result possible. However, many people who have been bitten by a dog will make the mistake of dealing directly with the insurance adjuster before consulting with a lawyer which could end up costing them money.

What evidence supports this fact? An Industry Institute study found that injured parties who hired a lawyer were able to get more money for their personal injury case, after paying a lawyer, than were individuals who attempted to represent themselves. So why would you not first get the advice of an experienced injury attorney?

Why would you let the insurance adjuster tell you what your case is worth when you don't know the first thing about personal injury law? The insurance adjuster will make promises to you that he or she will not be able to keep. In fact the insurance adjuster will do everything in his or her power to dissuade you from hiring a lawyer because the adjuster's chances of paying you pennies on the dollar, if you hire an experienced dog bite attorney, will be lost because you will now be represented by a professional who will help to level the playing field.

Chances are you will be contacted by the insurance adjuster of the person who owned the dog that bit you. This adjuster will tell you that your medical bills will be paid, your lost income will be paid to you and that the adjuster will work with you to help resolve your case as quickly as possible. The insurance adjuster will also want to take a recorded statement from you because, the adjuster will claim, that it will be necessary to get this information before processing your claim. These claims are false and you should never give a recorded statement to the insurance adjuster without first contacting an experienced dog bite injury lawyer because this could greatly compromise your claim.

How can you be sure?

If you doubt that the insurance adjuster is working with you to resolve your claim, first find out if the insurance adjuster, before you give any type of statement, will provide you with a letter indicating that their insured is 100% at fault for your injuries and damages (this is the easy one), that all of your medical bills will be paid as they are incurred, and that you will be paid your lost wages as soon as you submit documentation to the insurance company. The insurance adjuster will advise you that he or she cannot do that and you will know right away that this individual is not looking out for you but merely will be looking to line the pockets of the insurance company at your expense.

SO DO NOT TRUST THE INSURANCE ADJUSTER AND FIRST CONSULT WITH AN EXPERIENCED DOG BITE LAWYER!

So now you will understand why you cannot trust the insurance adjuster and what you must do to protect your interests.

MISTAKE #2

Not Getting The Dog Warden Involved, Filing A Report And Not Getting Proper Medical Care.

Now onto the second biggest mistake that people who have been bitten by a dog make complicate their recovery.

If you have been bitten by a dog it is very important that you contact the local police department or dog warden's office so that a proper investigation can be conducted, the necessary parties be interviewed, an investigation be conducted into whether or not the dog that bit you is up to date on its rabies vaccine, that the dog be quarantined and that a report be prepared. If your skin has been broken in any way, or if you have been knocked down or injured in any way, it is very important that you be taken to the emergency room of the nearest hospital. One of the greatest medical complications that can arise from a dog bite injury is getting an infection. If an infection is not properly treated, it could require that you be hospitalized, after undergoing a protocol for IV antibiotics an infectious disease specialist might have to be consulted to further treat you. You should also find out from the doctor at the hospital, what type of follow-up care and treatment you should receive to make sure that you get the best possible result from their dog bite injury. You should also seriously consider some type of psychological counseling if you suffer from sleepless nights, an overriding fear of dogs, anxiety or other psychological problems. It is very important that you monitor your physical and mental health on a very regular basis to make sure that you get treated by the proper medical professionals..

SO MAKE SURE YOU GET TAKEN TO THE HOSPITAL, BY AMBULANCE, FROM THE SITE OF THE DOG ATTACK AND INSIST THAT YOU GET SEEN AND STITCHED BY A PLASTIC SURGEON IF THERE IS THE CHANCE YOU WILL HAVE SOME TYPE OF VISIBLE SCAR. ALSO MAKE SURE YOU GET FOLLOW UP CARE FOR ALL NEEDED SPECIALISTS FOR ANY PHYSICAL OR PSYCHOLOGICAL COMPLICATIONS.

MISTAKE #3

Not Insisting Upon Being Seen And Treated By A Plastic Surgeon.

This brings us to the number one biggest mistake people, who have been bitten by a dog, make that can ruin their appearance.

If your dog bite injury has resulted in either a large wound or a wound in a prominent location such as on the face, then you need to INSIST that a plastic surgeon performed any type of cosmetic work on you. Many times the emergency room doctor will see you in the emergency room and then will stitch up the wound. A large wound or a wound that is located in a prominent place should be looked at by a plastic surgeon and any and all cosmetic work that needs to be performed should be done by the specialist. The last thing you want to do is have the doctor in the emergency room stitch your facial wound and then find out several days later, when you consult with the plastic surgeon, that it was not done properly and now the time to repair that problem has passed.

We have seen cases where a facial wound is stitched up by the emergency room doctor. Several days later the goes in to see a plastic surgeon and the plastic surgeon states that they would have performed the cosmetic surgery differently and that it will now be difficult to repair the damage that the original doctor caused. We have been contacted by clients immediately after they had been attacked by a dog and we advise them that no matter how long they have to wait in the hospital for a plastic surgeon to arrive that they should wait and not have the emergency room doctor stitched their face or other prominent location. If you do not consult with an experienced dog bite attorney as soon as possible after the dog attack you run the risk of either doing things that you should not be doing or not doing things that you should be doing. In either case you could severely jeopardize your recovery or you could reduce the value of your case. It is important that you contact an experienced dog bite or animal attack lawyer so that you understand your rights and the steps you should be taking. For example, if you are contacted by the insurance company of the person that owned the dog that attacked you NEVER give a recorded statement or speak with that individual unless and until you first get the advice of an experienced dog bite injury lawyer.
